



## **Information Notice on Video Surveillance in accordance with Art. 13 of Regulation (EU) 2016/679 and Art. 3.1 of the Italian Data Protection Authority Provision dated 8 April 2010**

Pursuant to Regulation (EU) No. 2016/679 (hereinafter, "GDPR Regulation" or "GDPR"), the applicable national data protection laws (hereinafter, together with GDPR, "Privacy Laws") and Art. 3.1 of Italian Data Protection Authority Provision dated 8 April 2010 (hereinafter the "Provision"), Mediobanca – Banca di Credito Finanziario S.p.A., with registered office in Milan, at Piazzetta Enrico Cuccia, 1 (hereinafter the "Bank" or the "Controller"), as Controller, must provide information on the use of personal data. Therefore, the Bank:

### **INFORMS YOU**

that at the office of Piazzetta Enrico Cuccia 1 and the premises at Filodrammatici 1/3/5, Milan, there is a closed circuit video surveillance system in place, operative in accordance with the authorisation received from the competent Local Labour Department ("DTL"), obtained in compliance with the Privacy Authority Provision of 8 April 2010.

#### **a) Purpose of processing**

Your personal data, specifically comprising images of you acquired by means of recording, is collected exclusively for the following purposes:

- a) security: CCTV usage means that we can protect the safety of company workers and/or collaborators and third parties;
- b) protection of corporate assets: CCTV helps us to prevent crimes such as thefts, robberies, damage and acts of vandalism.

Data is processed lawfully, even without your specific consent, in accordance with Art. 6 of the GDPR and in accordance with Art. 6.2.2.1 of the Provision.

#### **b) Processing method**

In relation to the purposes specified, personal data is processed using both manual tools, information technology and computer and telematic instruments, with logics that are strictly linked to the actual purposes. Processing takes place in such a way as to guarantee the security and confidential nature of said data in compliance with company policies incorporating applicable legislation in force at the time.

#### **c) Disclosure to third parties and dissemination of data**

Your personal information will not be disseminated and will only be disclosed to the legal or regulatory authorities or legal police when specifically requested.

#### **d) Minimum information notice**

Data subjects are specifically notified by means of the affixing of notices (simplified information notices) in the areas and premises subject to video surveillance. Said notices contain all information required by Art. 3 of the Provision.



## **e) Image storage time**

Images are recorded and stored in compliance with the requirements of the authorisation provision issued by the competent DTL.

Specifically, the data obtained shall be stored for up to 7 days; after this period of time, data will be erased by being recorded over, unless, as set forth in the DTL authorisation provision, the information is requested by the police or authorities or required to be retained for longer due to a criminal event, damage to corporate assets, unauthorised access to the premises by staff and/or third parties, crimes such as theft of company materials and products.

## **f) Rights of the data subject**

You have the right to obtain confirmation from the controller as to whether or not personal data concerning you is processed, and to know the contents and source, verify that it is correct or request that it be supplemented or updated, or rectified (Articles 15 and 16 of the GDPR).

In addition, you have the right to request the erasure of your personal data, the right to restrict the processing of such personal data, the right to withdraw your consent to data processing, the right to data portability, the right to lodge a complaint before the relevant supervisory authority and the right to object, at any time, on legitimate grounds to such processing (Articles 17 et. seq. of the GDPR).

The Controller, including through its designated departments, will handle your request and provide you, without undue delay, with information on the actions taken regarding your request.
